

# 7th Rally for Norlands: Civil War Reenactment Weekend October 9 & 10, 2021

## PARTICIPANT WAIVER – Mandatory

By attending and participating in this reenactment, I recognize that there are risks attendant to this activity, including, but not limited to, open campfires, handling and use of black powder, discharge of small arms and cannons, the risk of injury attendant to movement of large groups of people, the presence and use of horses and/or other animals and risks associated with primitive camping and that contraction of communicable illness and disease including but not limited to COVID-19.

I hereby assume any and all risks of danger occasioned by my presence and participation in any and all activities in any way related to the reenactment. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including but not limited to personal injury, disability and death), illness, damage, loss, claim, liability or expense of any kind arising out of or relating thereto.

On my behalf, I hereby release, covenant not to sue, discharge, and hold harmless Washburn-Norlands Foundation, their agents, assigns, employees, directors and officers; Third Maine Regiment Volunteer Infantry, their agents, assigns, employees, directors and officers; 15<sup>th</sup> Alabama Company G., their agents, assigns, employees, directors and officers of and from any and all claims for liabilities, actions, damages, costs or expenses of any kind arising out of or relating to property damage, personal injury of any kind, no matter how incurred, before, during or after participation in the activities and/or sustained during my presence at the reenactment or while on their properties.

**The Norlands is listed on the National Register of Historic Places and due to the historical nature of the buildings and the property, I specifically agree to follow the parking – non-smoking – no open flame – no pet rules established by Washburn-Norlands Foundation (aka: Washburn- Norlands Living History Center).**

**Parking:** I am aware that parking is allowed in designated areas only and that there is limited timeframes that cars are allowed near the campsites. Any infractions on my part may result in the towing, booting or deflation of tires of my vehicle at my expense. Any person found without a valid registration will be treated as an illegal trespasser and will be subject to the remedies and penalties as provided by the laws of the State of Maine.

**Smoking:** I am aware that **no-smoking is allowed within 50' of the buildings at Norlands**. Period correct pipes and cigars are allowed in confederate, civilian, and union campsites only.

**Open Flames:** While contained campfires are allowed in the confederate, union, or civilian camps, I am aware that there are to be no open flames, such as torches or lit candles. Candles and other sources of light must be enclosed through the use of lanterns or containers. I am also responsible for extinguishing campfires and other light sources at my campsite.

**No Pets:** For the safety and comfort of the animals and visitors, I am aware that no dogs or other pets, except for certified service animals, are allowed on the property during the encampment.
